Sl. No.	The school is directed to ensure that :
1	The total number of section of the school shall be restricted to 24 as per the number of sections reported during inspection, of which not more than 1/3rd sections may be used for senior secondary classes and number of students shall be restricted to 32 in 17 sections (as per dimension). Further increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law subject to availability of class rooms greater than 500 ft dimension.
2	On the first floor, school has shown a CwSN toilet, with signage for girl's toilet. However, a boys urinal constructed in the same. Therefore, the school is required to construct separate CwSN toilets for boys and girls on first floor with proper permanent signage (on the cubicle) as per norms of RPwD Act and Board's guidelines within 03 months and submit the compliance.
3	Biology lab is not covered in the review report. Therefore, the school is required to submit the videography link covering the same within 03 months and submit the compliance.
4	The school shall conduct training of its teachers with CoE Patna within 3 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.
